 - a. Update on RFA status and review of timeline
 - b. Question when we will know the budget? Dr. Kinney responded that we will not know officially until May, but are planning for a static budget (\$1M). This will allow up to likely fund 4 proposals
 - c. There are other efforts to increase the budget which would allow us to fund additional projects.

 - a. Updates OSPB and JBC
 - i. A strategy is to tie the ICR budget to the % of marijuana revenue in the state.
 - ii. Presentation was well received; Sal gave kudos to Drs. Bidwell and Kinney on their presentation.
 - b. Priorities
 - i. This has been discussed, but includes what was on the strategic plan document in addition to Dr. Hasan's suggestion below.
 - ii. With respect to the percentage of revenue related to marijuana sales in Colorado, which was discussed with the Governor's Budget Team and an emphasis area in the comments that were submitted with the annual report to the various state committee.
 - c. Donations
 - i. Dr. Kinney has had numerous conversations with Ean Seeb regarding donations to the ICR. Unfortunately this going through the State has not been successful. Therefore, Dr. Kinney has re-engaged with the CSU-Pueblo Foundation at the recommendation of Ean. There is still the challenge of donations from high-THC companies. The compromise has been to accept donations from individuals only. Dr. Kinney put together a proposal for the Foundations' Board for consideration.
