Summary of Request

The mission Institute of Cannabis Research (ICR) hosted at Colorado State University Pueblo is to conduct research related to cannabis and to publicly disseminate the results of the research. The traditional mechanism for the ICR to conduct research related to cannabis is through a statewide competition for research funding following national best practices. This engages the best researchers in Colorado to address the diverse research questions surrounding cannabis. This requests seeks to expand State supported cannabis research, as well as take steps towards the long-term vision of securing federal research dollars to support cannabis research in Colorado. The requested increase in appropriated Marijuana Tax Cash Fund (MTCF) dollars are to be used to directly support cannabis research in Colorado and increase research capacity in the ICR.

Current Program

The ICR was launched in 2016 through support from the State and Pueblo County. Initially the ICR activities were focused on cannabis research and education at CSU Pueblo as well as hosting an annual research conference. In 2019 the mission of the ICR evolved to a purely research and research dissemination focus that engaged researchers throughout Colorado. To accomplish this mission the ICR established a research funding opportunity modeled after the process employed by the National Institutes of Health (NIH) for research funding. That model was successfully launched in the fall of 2020 with research projects starting at the beginning of FY22. A second competition was held in spring of 2022 with projects to start in fall 2022. This competition is currently in the later stages of the review process. Information about currently funded research projects and previously funded research can be found on the <u>Research</u> page on the ICR website. The ICR continues to support and impact the rapid public dissemination of cannabis related research nationally and internationally by hosting the annual <u>Cannabis Research Conference</u>, sponsoring the publication of the <u>Journal of Cannabis Research</u> in partnership with Springer Nature Publishing, and hosting two <u>monthly webinar series</u>.

In FY 22 the ICR invested about \$950,000 into supporting research in Colorado and in FY 23 the ICR will support between \$1.8 million to \$1.9 million in research pending the final outcome of the research funding competition. Between the two research funding competitions managed by the ICR approximately \$25 million in research funding requests were submitted. The current budget request seeks to expand the ICRs ability to directly support cannabis related research in the State to meet the continued and evolving research needs. The remainder of the budget request seeks to support the development of ICR research capacity with an emphasis on maturing the ICRs research expertise and the ability to facilitate significant collaborative applications for federal research funding.

The ICR has generally looked to federal organizations in modeling our approach to meeting the research mission of the Institute. For example, the processes employed for the statewide research funding competition have been modeled after those employed the NIH. Likewise, as the ICR looks to mature as a research institute the need for development of internal research expertise and capacity has become a priority. This will be elaborated on in the next two sections.

There are ever-evolving public health issues, medical issues and applications, and scientific questions arising related to cannabis. In addition new cannabis and related products continue to emerge in the legal and illegal marketplace with unquantified risks. Applications of low THC cannabis (industrial hemp) continues to garner interest and continues to serve as an accessible material for research purposes. New applications for cannabis biomass as raw material for an even broader set uses continues to drive scientific and economic development. This is all to illustrate the need to support cannabis research. In the first statewide competition for cannabis research support, the ICR received high quality proposals from scientific research that can address many of the critical cannabis research questions. And in the second statewide competition this number grew to \$15 million.

Unbiased research informs appropriate regulations and policies to protect public health and safety; research stimulates medical, scientific, and technology advancements; and research addresses societal questions about the impact of new markets and policies. Colorado scientists are ready to do this work. To remain leaders in the cannabis space Colorado must invest resources to address critical cannabis research needs. The Institute of Cannabis Research (ICR) is committed to supporting unbiased cannabis research. The statutory role of the ICR includes conducting research related to cannabis which is primarily accomplished through funding merit-based research projects using national best practices in the selection processes. The ICR is well positioned to support the State in this effort to ensure that scientifically rigorous research is available to lawmakers and the public in making informed decisions.

Problem or Opportunity

The State of Colorado has been at the forefront of cannabis legislation and an early supporter of cannabis research. With the legalization of medical and recreational cannabis, Colorado has both an obligation and an opportunity to advance cannabis knowledge. The legal status of cannabis in Colorado has positioned the State to be a leader in cannabis research. The legalization of cannabis, new cannabis products, and varying methods of use represents areas of potential concerns. Simultaneously, the large number of biologically active phytochemicals in cannabis represents a treasure trove of possibilities. There are two facets to this budget request both of which directly address the ICRs role in conducting cannabis research.

The first facet is that Colorado has an opportunity to continue to invest Marijuana Tax revenue in research to explore potential therapeutic applications of cannabis or its derivatives (Medical and Clinical Research); research to ensure the protection of public health and wellbeing (Clinical and Public Health Research); research to understand the economic and social impacts of legalized cannabis and surrounding polices (Economic and Social Science Research); and research explore new applications of cannabis, its derivatives, and modifications of these derivatives (Biotechnologies). Colorado demonstrated the foresight to support the creation of an institute to facilitate cannabis research. However, the ability to maintain a leading role in cannabis research and preeminence, especially as more states and institutions are investing in cannabis research centers and institutes, may be in jeopardy. Colorado has the opportunity to remain at the forefront of cannabis research by incrementally increasing revenue from the Marijuana Tax Cash Fund into research in this State. These funds would be used to support researchers throughout Colorado. Beyond research outcomes, supporting research, especially at institutions of higher education, these resources provide opportunities for undergraduate and graduate student researchers to hone their skills to become the next generation of scientists and leaders in Colorado. Further, supporting such research supports the growth of businesses and industries, create new job opportunities, and attract students to higher education options in the state.

The second facet is the opportunity to invest in the research expertise and capacity housed within the ICR, and subsequently, the ability to effectively pursue federal research funding for the ICR. Further, this is an opportunity to model the ICR after federal agencies such as NIH and US Department of Agriculture, which serve both as research organizations as well as funding agencies. In doing so the ICR will become a more nimble institute able to directly pursue broader sources of federal funding and more capable of directly responding to the research needs of the

state. Additionally, the broader expertise housed withing the ICR will allow it to more effectively respond to legislative initiatives and better serve the needs of the State. These scientists will be available to liaise with legislators and staff to develop research priorities that align with scientific gaps and policy gaps/needs within the state. Currently the ICR has a single research scientist on staff whose back ground is plant biology and genetics. While this is appropriate to lead research in many important areas, it also misses many important areas such as analytical, medical, and public health research. Strategically expanding the research expertise within the ICR will allow for greater opportunities to pursue federal research dollars to support cannabis research in Colorado.

Proposed Solution

To address the opportunity to incrementally increase cannabis research in Colorado is to increase MTCF funds appropriated for cannabis research through the ICR in FY24 by \$1 million. This will allow the ICR to engage researchers in a statewide competition for research support on an annual basis and to fund multi-year projects at a rate commensurate with the resources required to conduct quality research that Coloradans deserve, including clinical and medical research. This would be an ongoing resource to maintain an annual cannabis research program.

To address the opportunity to expand the research capacity and expertise three additional staff researchers in the areas of Analytical Chemistry Research, Preclinical and Clinical Medical Research, and Public Health Research. While these researchers along with the current Senior Scientist (plant biology) will be provided modest base research funding, they would be expected to develop a statewide-collaborative, externally supported (i.e. federally and privately funded) research program. Further, these scientists will be available respond to legislative inquiries, cannabis research needs, and policy input. To best facilitate this a small amount of resources is requested to support contract grant writing support. Additional MTCF support of \$632,000 would be required for this.

Anticipated Outcomes

The outcomes of the proposed solution will be the ability to fund 3 new senior research positions to expand research capacity and expertise at the ICR to include analytical chemistry, preclinical/clinical medical, and public health research. This will allow the ICR to more effectively respond to legislative inquiries, pursue federal research funding in these research areas (leveraging State dollars to bring in additional federal dollars), as well as have the greater expertise to respond to the research needs and guestions from the State of Colorado. Further, these researchers will be expected to develop collaborative programs involving researchers from multiple Colorado institutions, thus developing resources that will support researchers throughout the state to address the most timely cannabis topics as they evolve. Combined, this will result in broad growth of Colorado's cannabis research portfolio. The outcomes of these projects will be publically disseminated as presentations at appropriate conferences, in the peer reviewed research literature, via reports to policy makers, via our publicly available webinars, and on the ICR's website. Research in these areas will contribute to new advancements that may translate to new industries, therapies, information that will directly inform State policy shaping the future of cannabis in the State. All funded research projects will undergo an annual assessment (progress report) to ensure appropriate progress is being made.

Assumptions and Calculations

The requested increase to the appropriation supporting the mission of the ICR will increase research funding by approximately \$1 million and expand research personnel by 3.0 FTE (\$194,000 per FTE). The estimate per FTE includes salary, fringe benefits, and base research support. An additional \$50,000 in contract grant writing support is included in this request. The balance of the increase in appropriation are for indirect costs (10% of direct costs). This will allow for continued funding of new research projects as well as expanded research capacity, expertise, and federal funding.
